# Dear Lakewood Water District Customer,

Thank you for a wonderful 2023! The District staff continues to work hard to fulfill our mission of serving healthy communities through responsible water practices. *Below are some highlights from the past year*.

#### PFAS

Understanding and addressing PFAS has been a priority for the District since we were first made aware of its detection on JBLM 2016. In 2023, the EPA announced a proposed MCL for PFAS that caused the District to move up its timeline for drilling new wells and installing Granular Activated Carbon (GAC) filtration systems. Staff have worked diligently to find funding through grants and low-interest loans. The District secured a little over \$18.4 Million of funding for four PFAS projects (\$8.4 million at 2.25%, \$10 million at 1.38%). The District also received grant funding \$3.85 million from State and Federal funds. These funding options allowed the District to go from a proposed 11.4% rate increase to 8.0%.

#### Summer Water Usage

As usual, our well-trained crew didn't miss a beat, pumping an average of 20.8 million gallons of water daily from June through August to meet the summer demands. The District's average in the offseason is about 11 million gallons per day (mgd).

#### Partnering to Save Money

The District continues to partner with the City of Lakewood on projects to save our ratepayers money! For example, partnering with the City on their Washington Blvd. project allowed the District to replace the water main as part of the District's R&R program, saving District ratepayers hundreds of thousands of dollars that the District would have spent if we had done the project ourselves. This is just one way the District is saving the ratepayers money.

#### **New General Manager**

The District has a new General Manager! Marshall Meyer, P.E. was promoted from Engineering Manager to General Manager effective December 1, 2023. Randall M. Black was the District's General Manager for the last 29.5 years. Randy is staying on as a Consulting Manager until he officially retires on February 28, 2024.

The District manages its Financial Policies as set by the Board to preserve the financial health of the District and maintain annual cash reserves at appropriate levels as prescribed in the policies. The District continues to adhere to its Five-year Rate Forecast as approved by the Board. Last year's forecast projected an 11.39% rate increase for 2024. With the continued rise of operating and maintenance costs including the District's steady investment in capital projects with an emphasis on mitigating PFAS compounds, the rate model continues to show a need for a rate increase. However, due to the hard work of securing grants and low interest loans and managing expenses, the updated forecast now shows a needed rate increase of 8.0% weighted average for 2024. As always, your Board continues to work hard to keep rate increases to a minimum.
