# THE PIPELINE

#### Pear Fellow Customers of Lakewood Water District,

We wanted to take another opportunity to share with you that in "The News Tribune," the final 2013 Budget for the District was presented to your Board of Commissioners for review and approval on December 20, 2012. After a very challenging budget process, the Board decided it could no longer underfund several maintenance programs that have been deferred in past budgets and agreed to a needed rate increase effective January 1, 2013. For a good number of our residential customers, this will mean another \$1.08 per month. We have budgeted the necessary Capital and Replacement & Rehabilitation projects in 2013 that will help maintain our good maintenance and operation standards, so we can continue to have a reliable system by which to deliver your good, clean, safe water.

The first bills to reflect the rate increase were received after March 1, 2013, to give you and all our customers a 60-day notice. A typical two-month billing for our residential customers in 2012 was \$27.24 for 1500 cubic feet of water consumed. That bill will now reflect an increase of approximately \$2.16 and become \$29.40 every two months, for an increase of \$1.08 per month. A comparison of the 2012 rate structure with the new rates is in the chart at the bottom of this page.

The 2013 Budget includes staffing to perform system maintenance that has been deferred in past years but is needed to maintain the system reliability our customers have come to expect.

Annually, by law, the Lakewood Water District is subjected to an extensive audit by the Washington State Auditor's Office. While they review all aspects of our operation, each year they pay particular attention to different elements of it, for example, the handling of cash: the proper investment of our funds; the application of appropriate accounting principles in the preparation and maintenance of our financial reports; and that meetings of the Commissioners are conducted and reported pursuant to applicable statutes.

We are delighted to report that for the year 2011, for which the most recent audit was completed, we received a totally "clean" report. In fact, it was the 17th year in a row that the District had zero findings. We also received many compliments from the auditing team on how the business of the District is conducted, the cooperation of our staff in the performance of the audit, and our willingness to seek advice from the Auditor's Office during the year as questions arise. Compliments to General Manager Randy Black and Finance Director David Logan along with all of our employees who participated in this year's audit.

### SEASONAL FLUSHING **COMING YOUR WAY:**

Lakewood Water District staff will once again be performing the annual flushing of our water mains starting March 18 through May 10. We perform high-velocity flushing of our system, pulling water from a storage tank or reservoir, then proceeding from hydrant to hydrant, turning them on full speed out of the front pumper port. This action causes a scouring of the inside of the water mains.



Flushing occurs between the hours of 8 a.m. and 4 p.m. Blue-and-white street notification signs will be placed in your neighborhood 48 hours in advance to let you know when the District's flushing crew will be coming to your area.
