RESOLUTION NO. B-1419

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF LAKEWOOD WATER DISTRICT OF PIERCE COUNTY, WASHINGTON, DECLARING CERTAIN DISTRICT PERSONAL PROPERTY SURPLUS AND DECLARING THE DISTRICT'S INTENTION TO SELL THE PERSONAL PROPERTY AT PRIVATE OR PUBLIC SALE.

WHEREAS, Lakewood Water District ("District") owns certain personal property as further described on **Exhibit A** attached hereto and incorporated herein by this reference (the "Property"); and some of the Property may be identified in the District's accounting and property records as "fixed assets"; and


WHEREAS, District management staff have advised and recommended to the District Board of Commissioners the (1) District does not and will not need the Property for District purposes or otherwise, (2) the Property has an estimated value of more than Two Thousand Five Hundred Dollars (\$2,500), and (3) the Property should be sold at private or public sale as appropriate in accordance with RCW 57.08.015; now, therefore,


BE IT RESOLVED by the Board of Commissioners of Lakewood Water District of Pierce County, Washington, as follows:

1. The Property as described on **Exhibit A** is not and will not be needed for District purposes.
2. The District hereby declares the Property to be surplus to the District's needs and further declares its intention to sell the Property at private or public sale pursuant to the requirements of Chapter 57.08 RCW.
3. District management staff are authorized and directed to sell the Personal Property at private or public sale as staff deem appropriate, and to remove the Property from the District's list of fixed assets.
